US Supplier Diversity Definitions

HUBZone Small Business (HZ)

A small business concern located in a "historically underutilized business zone," owned and controlled by one or more U.S. Citizens, and at least 35% of its employees must reside in a HUB Zone. It must appear on the list of Qualified HUBZone Small Business Concerns maintained by the SBA.

The certifying agency is the Small Business Administration.

Large Business (LBE)

A business that does not meet the federal government's definition of small, which measures annual revenue and employee headcount, in accordance with the Small Business Associate numerical size standards as defined in the Small Business Size Regulations.

Minority Business Enterprise (MBE)

A business that is at least 51 percent owned by one or more minorities groups: Black, Hispanic, Native America, Asian Pacific or Asian Indian.

The certifying agency is the National Minority Supplier Development Council.

Service-Disabled Veteran Business (SDVB)

A business that is at least 51 percent owned and controlled by one or more service-disabled veterans, the home office must be located in the United Sates and the home office cannot be a branch or subsidiary of a foreign corporation, foreign firm, or other foreign based business. Service-disabled veteran means a veteran, as defined in 38 United States Code 101(2), with a disability that is service connected, 38 United States Code 101(16).

This is a self-certifying designation as no formal certification exists for this classification

Small Disadvantaged Business (SDB)

A "for profit" business concern: (1) that qualifies as "small" per the SBA Table of Small Business Size Standards Matched to North American Industry Classification System Codes, (2) that is at least 51 percent unconditionally owned by one or more U.S. citizens who are socially and economically disadvantaged individuals, (3) whose management and daily business operations are controlled by one or more U.S. citizens who are socially and economically disadvantaged individuals, and (4) the personal net worth of each individual claiming economic disadvantage is less than \$750,000 "Socially disadvantaged" individuals are those who have been subjected to racial or ethnic prejudice or cultural bias because of their identity as members of a group.

SDB is a self-certifying designating as no formal certification exists for this classification.

Small Business (SBE)

A business, together with its affiliates, that is independently owned. The Small Business Administration (SBA) determines small business size standards on an industry-by-industry basis. This is reflected in the table of size standards that are matched to the North American Industry Classification System (NAICS) industries. This is a self-certifying designation as no formal certification exists.

Veteran Owned Business Enterprise (VOBE)

A business that is at least 51 percent owned and controlled by US citizens who are Veterans of the US Armed Forces.

This is a self-certifying designation as no formal certification exists for this classification.

Woman Business Enterprise (WBE)

A business that is at least 51 percent owned and controlled (management and daily operations) by one or more women of US citizenship or US Legal Resident Alien Status.

The certifying agency is the Women's Business Enterprise National Council.
